Item 5.7 was pulled from consent calendar for discussion by the Board of Director.

5.7 Discussion, Direction and Possible Approval on Engine-16 with included options.

Chief Hall reported that Engine 16 failed pump test and that the repair cost would be approximately a minimum n of \$7,500.00. He would like direction from the Board regarding the options which are available.

- 1) Pay the \$7,500.00 to repair
- 2) Purchase a new pump, which would be more expensive than the repair.
- 3) Buy a new-used fire engine (copy of online bidding sheet given to Board to review).

Chief informed the Board that there is a used fire engine, which was owned by San Ramon Fire District, that is online and San Ramon are requesting bids on this fire engine. It is a 1995 w/ 800 gallon pump and the high bid is currently \$45,000.00.

Board requested that this item be discussed in closed session.

7. **Staff and Committee Reports: Fire Chief's Report:**

7.1 **Board Meeting Reports**

7.1.1 **Stanislaus County Fire Authority Meeting Update.**

Director Kimball did not attend the meeting. Chief Hall updated the Board on the meeting. Discussion; *ISO grading is changing with more rating being used in the training area. There was also some discussion regarding the *Regional Fire Training Center of which agencies originally joined and what agencies pulled out due to lack of use of the facility.

7.2 **Chief's Report:**

7.2.1 **Legislation – Update:** *Nothing new to report.*

7.2.2 **SRA Fees:** *SRA fee invoices were sent out and residents are receiving their tax bill of \$150.00 and the people are not wanting to pay this fee.*

7.2.3 **Diablo Grande inquiry:** *Diablo Grande resident will be receiving this billing from the State of CA, because they are in the "State Responsibility Area" Supervisor De Martini well be meeting with the residents in Diablo.*

7.2.4 **Property Tax Administration Fees- City of Alhambra vs. County of Los Angeles**
Liaison Gaiser explained the tax collection process that Stanislaus County uses to process the collection of the property tax for the special district in Stanislaus County. Board would like staff to check and see if there is administrative fee being charged to Our District.

7.3 **Fire Consolidation Study – Update**

7.3.1 **Appointment of new City of Patterson Council Member.** Chief Hall updated the Board with the status of the Patterson City Council.

7.3.2 **Set Date for Next Meeting:** Chief Hall will work on setting up a date for the next meeting for the member of the Consolidation Committee.

7.4 **Joint-Positions Recruitment – Employee Introductions**

7.4.1 **Training Captain Mike Ambrosino:** After the interview and testing process Mike Ambrosino was chosen to fill the jointly-shared position between the City of Patterson and the West Stanislaus Fire District. Mike started as a Volunteer Firefighter, then was hired by the City of Patterson as "Career Firefighter" and was promoted to a Fire Captain. So he is very familiar with our departments.

7.4.2 **Fire Prevention Specialist Carrie Silveira:** After the interview and testing process for the Fire Prevention Specialist position, this is also a shared position between the City of Patterson and the West Stanislaus County Fire Protection District. Carrie Silveira was chosen to fill this position. She is the daughter of Retired Volunteer Assistant Chief, Allister Allen. She has prior fire prevention inspection experience with the City of Turlock.

7.5 City of Patterson Public Safety Facility

7.5.1 **Fire Administration, Law Enforcement, and Emergency Operations Center:** Chief Hall reported to the Board that the City of Patterson looking into buying the "Frontier Building" in the Keystone Business Park. This would be used for a "Public Safety Center". Fire and Police would share this location. The City of Patterson has an Architect (Chris Ford) to re-design this building. There would be no cost to the Fire District for this preliminary review.

7.5.2 **Joint Use Agreement:** If this change in location occurs, then the City of Patterson & West Stanislaus Co. Fire District would need to have this "Joint Use Agreement" in place.

7.6.1 **Captain Jonathan Schali- Patterson**

Chief Hall report to that City of Patterson Firefighter's Jonathan Schali and Marty Greunke were both promoted to Captains.

7.7 Operations/Training (Division Chief Breasher)

7.7.1 **Basic's Program-Update:** Division Chief Breasher updated the Board about the Basics Class. The class is down to nine (9) recruits and that they are doing great. This Saturday (December 8th) there was an "All Hands Drill" – Firefighter Survival /RIC / Large Area Search training and Recruits really enjoyed this training.

7.7.2 **Target Solutions (On-Line) Training- Update**

7.8 Apparatus/Facilities (Division Chief Gregory)

7.8.1 **Flag Pole Lighting, Crows Landing Station:** Division Chief Gregory reported that he is still working on this project, but should be completed soon.

7.8.2 **Water Tender Number 3 - Project:** He has the "Bid Request Packet" almost done and should be going out soon. He also let reported that Westley-El Solyo Volunteers' will be contributing 60,000.00 towards the cost of this engine.

8. **Other Matters:** Director Kimball he was talking with Cal-Fire Chief Steve Barrett and he said he was going to retire soon, but he will still be around working on current ongoing projects.
9. **Closed Session (if any):** Board went into closed session at 3:20 p.m.
10. **Reports from Closed Session (if any):** Discussion of item "5.7 – Direction and Possible Approval on options for Engine 16 (failed pump test / cost for repairs \$7500.00)

All Board members agreed that the best way for the Fire District to proceed, would be possibly purchase a used-new fire engine with the online bidding process.
